



HSR REFRESHER OHS TRAINING COURSE

This WorkSafe approved HSR Refresher course is an opportunity to revisit aspects of the HSR Initial OHS Training Course. It will help attendees refresh their knowledge of the application of the OHS Act, Regulations and Compliance Codes within their workplace.

Under the OHS Act 2004 (section 67) all elected HSRs and Deputy HSRs have an entitlement to attend an annual HSR Refresher OHS Training Course and in consultation with their employer, choose the course they wish to attend.

The Act also requires employers to pay course fees and other associated expenses for reps attending training. Employers must be given at least 14 days' notice of a rep's intention to attend a course of training.

The course is limited to a maximum of 16 participants
